


Hereinafter referred collectively as "TRUSTEES"

And whereas with a view to and the purpose of constituting the TRUST permanently as an irrevocable TRUST for thepurpose of carry on the objectives of the TRUST as mentioned hereinafter under the "Aims and Objectives" clause for the deed of TRUST.

Now the deed of declaration of Trust witnessenth:-

- 1. NAME AND OFFICE OF THE TRUST:
- a) The name of TRUST: NUR MOHAMMAD SMRITI MAHAVIDYALAYA ALUMNI ASSOCIATION

- b) The office of the TRUST be located at <u>VILL- DACKBANGLOW, POST-RATANPUR</u>, P.S.- SAMSERGANJ, DIST.- MURSHIDABAD, W.B, PIN.-742202.
- c) TRUSTEES shall have the power to shift the office to any other place in India or open local offices at places deemed necessary.

2. <u>INTERPRETATION</u>:

- a) TRUST means the TRUST created by this deed viz. "NUR MOHAMMAD SMRITI MAHAVIDYALAYA ALUMNI ASSOCIATION"
- b) The "Board "shall mean the Board of Trustees created by the Deed.
- c) "Trust Property" shall include every kind of property movable and immovable owned by the TRUST and mentioned in account books and other documents in the custody and control or that ought to be in the custody and control of the TRUST.
- d) It is Declared and Confirm that the Trust is Irrevocable.


3. AIMS AND OBJECTS OF THE TRUST:

THE AIMS AND OBJECS FOR WHICH THE TRUST IN ESTABILISHED ARE:-

- 1) To promote Social, Educational and Economical upliftment and General Welfare of the people, especially for the people of the WEST BENGAL And neighbour state of this country.
- 2) To start, takeover acquire and maintain or manage Nursery School, Primary, upper primary, High school, Madrasah, Polytechnics, Libraries, reading room, study centre, Vocational Training Centre, Craft Training, Garmin Small Cottage Industries, Handicraft Institution, Free Treatment Hospital, Cottage for older aged person, and production centre for the promotion of education and vocational skill among the boys, girls and women of the general and Backward classes.
- 3) To arrange and manage the interest free banking system in order to provided the loan to the financially weaker section of backward classes.



- 4) Po constitute committee etc. for the development of education, health, socio economic condition, communal harmony and to eradicate illiteracy, short coming and superstitions from the society.
- 5) To establish and maintain Adult Education centre, especially in rural areas and in slums for eradicating illiteracy and ignorance, financial help to the poor bride, for marriage ceremony and to appoint teachers and supervisor for the management of such centre.
- 6) Po start, set up, acquire take over run, maintain or manage Agriculture Training Centre and firms, fishery, and poultry Training Centre, Fruits Processing Training Centre for the economic social uplift men of the people.
- 7) To Conduct and organize seminars, symposiums, get-together public meeting to create and develop communal Harmony, peace, and to eradicate and abolish communal hatred and ill feeling among the people.
- 8) To award scholarship for the deserving people and student for technical, medical, professional, Islamic and General Studies and also to provide financial assistance for deserving students to get abroad for higher studies or grant interest free loan for self employment and for such purposes.
- 9) To encourage athletic activities of youth and student and conduct tournaments, sports and game for them.
- 10) To establish and run hostel, Literacy centre, boarding houses, dormitories for student and teachers and others in need of such assistance and care.
- 11) To open Health centre, Hospitals and Nursing Home and to give aids to such institutions and also to organize medical check-up centre and health care camps.
- 12) To organize relief camp, relief work in the event of natural calamities, communal riots and upheavals in any part of country.
- 13) To associate, co-operative and collaborate with and assist any other societies having similar aims and objects.







- 14) To create and accept donation, charges, fees, gift, benefactions bequest and grants in such or kind from public, institution and Government, Semi Government, Non Government organizations and from abroad for achieving the object of the trust.
- 15) To organize movement in order to remove the dowry System from our society.
- 16) To publish to be Published useful literature papers, magazine books etc.
- 17) To help the needy student of all communities for prosperity of students.
- 18) To organize an eye operation camp for the people belonging to helpless, poor, undeveloped economically down trodden villages of this areas.
- 19) Children are the Future of the nation. In these regards the trust will take up a special plan for the proper growth and development of the children, by child specialist.
- 20) To take up the programmed for the general awareness of the people to save them from deadly diseases i.e. Aids, polio etc.
- 21) It is declared and confirm that the Trust is Irrevocable so as to aligned to its main object.
- 22) To enrich and enhance social economical condition of our students.
- 23) To create Job opportunity.
- 24) To make them conscious and aware about health sports and social harmony.

4. RAISING OF FUND AND EXPENDITURE:

And for achieving any or all the above objects to raise funds through donations, grants and contributions and to obtain and receive deposits and loans from Banks and other Financial Institutions, Individuals, associations, firms whatever and to invest and deal with the money and funds belonging to the TRUST not immediately required in such manner as may from time to time be determined by the Board of Trustees subject to the provisions of the Law of the land, and to take on lease or purchase or accept by way of gift and land, building or any other property both movables and immovables and to remunerate any person, firm or institutions for services rendered to the TRUST in any capacity and to pay out the funds of the Trust all costs, charges, expenses incidental to the establishment, registration and

Advertisements of this Trust and to adopt and take such other lawful means as may be incidental and conducive to the accomplishment of all or any of the above objects and shall also receive grants and donations from Foreign Governments, organization, institutions or agencies and individuals according to the prevailing Law of the land.

5. CONTROL OF THE TRUST:

The properties and funds shall vest in the Board of Trustees constituted by persons executing the Deed of Trust. The number of members of the Board of Trustees shall not exceeding 3 (Three). If there are vacancies at the time of execution of this deed the same can be filled up by co-option of the Board of Trustees.

Provided that the Board of Trustees is authorized to create any other posts of office bearers and elect other office bearers to fill up the posts among the Trustees. The above office bearers shall be elected from among themselves by a majority of the Trustees at a meeting convened for the purposes.


- 7. **QUORUM**: 1/3 shall be the quorum of any meeting.
- 8. <u>VACANCIES</u>: A VACANCY SHALL ARISE AMONG THE Trustees in the following cases:
 - a) When a Trustee dies.
 - b) When he / she resigns.
 - c) When he / she is absent from three consecutive meeting of the Board, unless the board record condoning such absence.
 - d) When he / she becomes insolvent.
 - e) When he / she is convicted of any criminal offence involving moral turpitude.
 - f) On medical evidence that he/she is declared physically or mentally unfit by a resolution of the Board at a meeting convened for the purpose.

In case of any vacancy arises among the Trustees new Trustee shall be nominated and / appointed and such person shall be of sound mind, above 18 years of age and who shall subscribe to the object of the Trust. The Board of trustees then by a 2/3rd majority of the existing Trustees attended the meeting convened for the purpose, shall fill up the vacancies arising in the Board of Trustees and also increase and include more Trustees.

9. TERM OF OFFICE:

The Board of Trustees shall elect office bearers from among themselves within a month of the formation of Trust. They shall remain in office for 4 (Four) years. The Board will elect office bearers for the next terms within a month of expiry of the term.







10. POWER OF TRUSTEES:

The Board of Trustees shall have the following power:-

- a) To call for and collect and receive funds and such funds may be utilized by them for such purposes and objects of the Trust as they deem fit.
- b) To accept and receive contributions, donations, gifts and grants.
- c) To acquire movable and immovable property by purchase or otherwise
- d) To erect or cause to be erected buildings or building equipments and machinery for the benefit and attainment of the objects of the Trust.
- e) To sell, transfer, exchange, alienate or mortgage movable or immovable properties belonging to the Trust.
- f) To manage administer and control properties and all assets of the Trust directly or indirectly and all institution connected with the Trust.
- g) To demand, call for and realize money and other assets due or belonging to the Trust and issue receipts and vouchers for the receipt of the same.
- h) To employ necessary staffs for the management, administration and running of the Trust in general and for the institution in particular and for the purpose of carrying out the objects of the Trust on such terms as may appear proper to the trustees and to delegate and to allot to such staff from time to time such powers and duties as may be necessary in the usual course of business,
- i) To appoint from time to time and at any time to suspend, dismiss, remove or discharge any person under their control including clerks, accountants, and to reemploy them with such powers and duties and upon such either by giving one month notice or by giving one month salary as the Board of trustees shall think proper.
- j) The Board shall have the full power to make, amend, delete or rescind rule and bylaws of the Trust.


k) To do all acts and things which are connected with the administration of the Trust in general and of the institutions in particular and which are deemed by the trustees to be in the best interest of the Trust and desirable.

11. FUNCTIONS OF THE OFFICE BEARERS:

The function of office bearers is maintained as per laws or customs of the Indian Trusts Act, 1882.

- a) <u>President</u>: President will be elected by the majority of the members (trustees) present in the meeting convened for the purpose. The president is empowered to take decisions on urgent matters but his decisions should be approved by the board. The president will preside over the meeting of the trust and conduct the proceedings. The president is empowered to resolve committee or the board in any abnormal situation.
- b) Secretary: The secretary of the board of trustees, elected under the control and supervision of the board, shall conduct and manage all the affairs of the trust, its properties and institutions, sign papers and carry on correspondence on behalf of the trust, and shall be responsible for the safe custody of records of the trust and the keeping of proper accounts thereof. The secretary shall carry out all the resolution of trust and for the purpose shall have power to incur necessary expenditure form and out of the trust, he said have the custody of the correspondence and other books relating to the affairs of the trust.
- c) <u>Treasurer</u>: The treasurer shall collect and receive all sorts of subscriptions, donations, and deposit of money and grant receipt of money thereof. He will maintain and keep cash book and such other accounts as are necessary.

12. APPOINTMENT OF EMPLOYEES:

The board shall have also power to employ necessary staff for management, administration and running of the trust in general and of the institution in particulars on search reasonable salaries and remunerations and such terms as may appear proper to the trustees for managing the affairs of the trust and the Institution and for the purpose of achieving of the object of the trust. They may be allotted or entrusted with search duties and responsibilities as the board would deem fit. It shall be competent to the board to remove the staff referred above without assigning any reasons thereof, one month notice or payment of one month's salary.

13. RECEIPTS OF CONTRIBUTIONS:

All the money should be received only on account of or in the name of the TRUST and receipts should be issued under the seal of the Trust and must be signed by the President or Secretary or the persons authorised by the Board by a resolution recorded in the minute book. No money or property shall be received or used except for the purpose and objects of the Trust.


14. BANK ACCOUNTS:

The bank account operators will be there office bearers. They are secretary, president and treasurer. The board has right to change the signatories of this purpose in a meeting convened for this purpose and with 50% majority.

15. BOARD MEETING:

a) A meeting of the board Shall be held ordinarily at least once in 6 months or earlier on the requisition of at least 1/3 of the Trustees to consider the affairs of the trustand all the proceeding of the preserved by the secretary on behalf of the trust.







Notice of every meeting of the board together with the agenda shall ordinarily be given by the secretary or conveners to all the trustees at least 7 (Seven) clear days before the proposed date provided that in case of emergency there will be no time limit for serving the notice.

- b) If was delivered to the trustee personality or if such notice was issued to the last postal address furnished to the office of the trust by the trustee concerned and 1. Posted within a reasonable time so as to presume that the notice should have reached the addressee (trustee) in the due course or 2.served on any such person of the said address of the Trustee concerned.
- c) The chairman of the board of trustees shall preside over all meeting of the board of trustees in absence of the chairman of the Board of Trustees in the meeting; the vice- chairman shall preside. In the absence of both the trustees present therein may elect a chairman from among themselves to preside over the meeting.
- d) Every question which shall arise at any meeting of the board shall be decided by a majority of voters of the trustee present and in case of the equality of voters, the chairman of the meeting shall have a second or casting vote, but in no other event shall any trustee have more than one vote and there shall be no vote by proxy.
- e) The proceeding of every meeting shall be entered in the Minute's book maintained for the purpose and signed by the trustee present at the meeting. Chairman and the secretary should sign at the end of the proceedings of each meeting.
- f) No preceding of the meeting of the board shall be invalid.

16. IMMOVABLE PROPERTIES OF THE TRUST:

No immovable property belongs to the Trust shall be sold, exchanged, transferred, converted, mortgaged or alienated in any manner whatsoever except when such exchange, transfer, conversion or alienation:


- i) Is imperative in the interest of the Trust and Institutions and Department connected therewith,
- ii) Is not likely to adversely affect to any extent whatsoever the existence and benefit of the Trust, Institution and departments connected therewith an object of the Trust, and
- iii) Is decided to that effect by the Board in its meeting by a resolution passed by majority of the Trustees present.

17. SUITS AND LEGAL PROCEEDING:

The Board or any one or more of the Trustees may apply for advice or the directions to the Court as occasion may arise. The Board of Trustees may apply may sue or to be sued in the name of the Secretary of the Board. The Board may by a resolution passed specially or generally in that respect at any time and from time to time authorize any of the Trustees by power of Attorney or otherwise.

- To institute, conduct, defend, compound, withdraw or compromise, adjust, refer to arbitration or abandon any legal or other proceedings, claim or disputes, or against the Trust or Trustees or against its officers or employees concerning the affairs of the Trust and to sign and verify vacillate, plaints, statements, affidavits and other proceedings before all Courts, Tribunals and other Government authorities both Central and State.
- ii) In entering into any agreement or contract or in executing and registering any document,

- Generally in doing and performing any act, deed, matter of things whatsoever iii) which has to be done, executed and performed by the Board of Trustees or Trustees as the case may be in relation to any property, business affairs and matters of the Trust and / or of the Board and/ or Trustees as in/are principal / principals.
- The Board may take other step it may deem fit to meet any contingency affecting iv) the Trust in any legal proceedings or any other matter.

18. OFFICIAL YEAR:

The official year of the Trust shall be 1st April to 31st March of each year or it will be changed as per circular of Govt.

19. WINDING UP OF THE TRUST:

In case the Trust activities could not be continued for any reason, the property, funds and assets of the Trust that may remain after full satisfaction of the liabilities of the Trust will be transferred, paid and handed over to any trust society or institution established for achieving similar aims and objectives provided that-


- Notice of such meeting is served on all the existing Trustees, i)

21. <u>INVESTMENT:</u>

The investment of the Trust assets shall be made as per the provisions of the Income Tax act, 1961

22. AMENDMENTS TO THE SCHEME:

If any time it is found that alterations in any of the provision of the Trust or scheme for the purpose of effective achievement of the object of the Trust are imperative and very essential, then the Board shall approve such alteration by a resolution passed in its meeting and thereafter the modification shall become part and parcel of the terms, condition and provisions of this Trust and of this scheme. The Board may at any time and from time to time make, amend, delete and rescind rules and bylaws for the conduct of this business, for the control, management and administration of the Trust made under this Trust deed and for carrying out the objects of the Trust relating to any matter under this scheme, provided that such rules and bylaws shall not be inconsistent with or repugnant to any provisions of the scheme of the Trust.

23. DECLARATION:

THIS Trust and the scheme set forth under this indenture shall come into force immediately after the execution and registration thereof. The Trustees above named also hereby declare that they have consented to the Trustees under the Trust accepted and the Trust have taken delivery of the possession de jure and defect of the schedule fund of price and that in witness whereof the Settler above named as parties herein has affixed his signature hereunder.

All aims/objects/purpose of the trust herein stated above shall come into effect/force after necessary approval of the competent govt. Authority in the cases where affiliation/permission licence/sanction is required.

The Trust-will never act which are illegal and unlawful in nature and also oppose to the public policy and contrary to the law of the country.

The Trust will never act like Micro Financing and Money Laundering in nature.


